# Colorado Springs Storm Volleyball Club

## 2024-2025 Player Financial Agreement

This Agreement is between Colorado Springs Storm Volleyball Club, "The Club" or "Storm Volleyball", and the above listed Player and Parent(s) for the team listed at the top left of this agreement. The agreement is from July 23<sup>rd</sup>, 2024 till May 31<sup>st</sup>, 2025 and covers the time period commonly referred to as Club Season. Player and parents agree to play exclusively for Storm Volleyball and no other clubs during the dates listed and Storm Volleyball agrees to provide a spot on the listed team and train player in volleyball during the season. While Storm Volleyball strives to foster the development of each player, there is no guarantee of playing time in tournaments.

Parent acknowledges that each team member is responsible for their portion of the total season expenses. If a player cannot complete the season, they are still responsible for the entire amount of dues per this agreement. Reasons for not completing the season include, but are not limited to, moving, injury, sickness, removal from the team for breaking club rules, and quitting for any reason. The Club agrees to limit the team size to eleven players. Dues are based on the eleven players. Refunds will not be issued to parents for players not finishing the season for any reason.

Club Dues under this agreement will be two thousand six hundred dollars (\$2,600.00) and are due based on the following schedule. An initial dues payment of \$500 will be due at Club tryouts on July 23<sup>rd</sup>, 2024. Then six equal monthly payments of \$350 will be due on the 10<sup>th</sup> of the month beginning in August 2024 and will continue monthly until the final payment, which is due on January 10<sup>th</sup>, 2025. The balance of dues may be paid in full at any time before the due dates. Payments made after the 10<sup>th</sup> of the month will be considered late. Player's ability to practice will be affected if dues payments are late. Payments may be made in person at the facility in cash, check, or credit card. The Storm Volleyball website will also have a parent portal in which credit card payments for dues will be accepted. Parents agree to pay all costs of collection including attorney fees should the Club have to enforce this agreement.

Club dues under this agreement will include the following: uniform package, all coaches pay, all court time for team to practice (all teams will have a minimum of two practices per week and some weeks may have three), and entrance fees to tournaments. Parents will also be required to pay to enroll their players in the RMR (USA Volleyball) and the Centennial State Series (AAU Volleyball). Cost for this enrollment will be approximately \$110 for the entire season and will be due in early September 2024. All other expenses, and expenses for Storm Club Volleyball coaches, will be paid by the Club from the player dues. Dues include only tournaments in Colorado. Any travel by teams out of state will be an additional cost and will be agreed upon by teams at the pre-season team meeting. Most teams will not travel.

Parent authorizes Storm Volleyball staff to act in their behalf, and in Storm's best judgement, in any medical emergency. Parent agrees to pay any and all cost arising from such an emergency. Parent also authorizes the Club to use the player's image and likeness in any promotional material or social media during the course of the season.
